

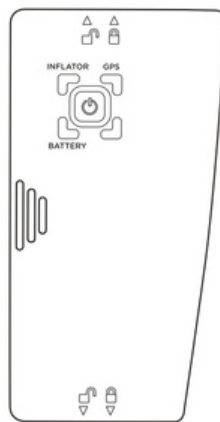
## Guidelines for air transportation of In&motion electronic airbag products

This document applies to the following elements:

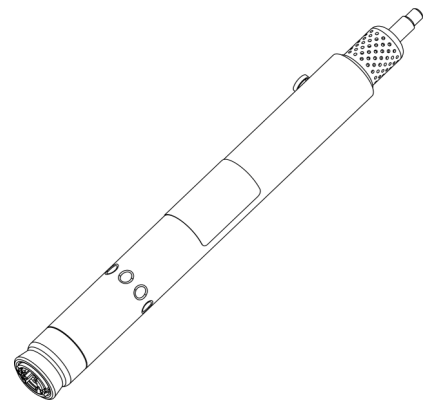
- The **airbag product** (containing the airbag system)
- The **In&box** (electronic device containing a battery)
- Spare **inflators** (gas generators)

### Airbag product

- The airbag product is a single self-inflating personal safety device fitted with 1 or 2 inflators (gas generators) securely screwed into the airbag system.
- The airbag product is not classified as a dangerous good.
- Always **remove the In&box** from the airbag product when travelling by plane.
- Up to two (2) airbag products may be transported in the **checked baggage** or as **carry-on luggage**.

### In&box

- The In&box is a portable electronic device containing a lithium-polymer battery.
- The In&box is classified as a dangerous goods according to the Federal Aviation Administration.
- The In&box must be **switched off, removed** from the airbag product and transported in the **carry-on luggage**.

## Spare inflators

- Spare inflators are dangerous products belonging to **UN3268 - Class 9** according to the UN Dangerous Goods Classification.
- Up to two (2) spare inflators may be transported in their original packaging in the **checked baggage** or as **carry-on luggage**.
